

Letter of Assignment

for Investing in the Trading Forex and Commodities

The Potential Investor has read and accepts the conditions, assigning the financial company "Progress Investments Corporation", from hereon referred to as "Progress", to carry out, manage and attend to, in the stead of the same, the Investment in the exchange market denominated Forex and of the raw materials from hereon referred to as "Commodities".

1. The Potential investor, interested in increasing his earnings, entrusts "Progress" with investing his/ her capital, with the purpose of optimizing said investment, in the Forex and Commodities market.
2. The compensation due to "Progress" for said services is equal to 9% of the profit deriving from the investment. Said compensation is recognized only, and exclusively, in the case that the investment produces positive results. Nothing is recognized if there is no profit.
3. In order to render profits deriving from said investment more concrete and substantial, "Progress" collaborates with Brokers, Traders and Financial Institutions of the greatest importance and economic strength and soundness (solidity), which have the most technologically advanced means at their disposal for obtaining success.
4. The potential Investor knows the risks that are linked to said activity, because in any case it is an investment, so the Investor must invest his/ her capital gradually, objectively and cautiously, without feeling forced.
5. The potential Investor, completely autonomous and unconditionally, chooses and then notifies "Progress" the sum he/ she wishes to invest, checking the desired amount here below:
6. The potential Investor, after having accepted the present conditions and having sent the Assignment Letter, must follow-up by sending the sum that the potential Investor wishes to invest, following the procedure listed under the section **How to Invest** in the website www.futureinvestments.org.
Any money that is sent must be done directly between the Potential Investor and Progress Corporation. No one other than "Progress" has been authorized to receive funds. The payment of any sum to third parties exonerates "Progress" from all responsibility toward the potential Investor.
7. The potential Investor knows that the investment report and any other communication will be sent by "Progress" on a quarterly basis. The potential Investor will also receive the payment of the earnings from the investment on a quarterly basis. (Today in Italy these are retained by law and tax exempt.)
8. The potential Investor, in as far as the state of the investment allows, has the right to request the restitution of the capital he/ she has invested at any time. The restitution of all or part of the invested sum does not involve any fine regarding the capital.
The request for the restitution of the sum, if made before 36 months after the deposit date results in the loss only of the profits obtained up to that moment, while the available capital will be sent within 7 work days from the request.
The request for the capital that has been invested made 36 months from the deposit date will not result in the loss of either capital or profits.
9. Later capital investment cannot be added to previous investments.
A new deposit is considered as a new account and is subject to the acceptance of a new Assignment Letter with the conditions of "Progress" applied at that time.
10. The potential Investor pledges to invest only sums originating from legal activities.
11. The present Assignment is subject to privacy and the information herein, will not be made known except in the case of improving the investment, and will remain reserved.
12. In case of controversy, the laws of Panama will be applied.
